Chairperson Martha Morgan called the regular meeting of the Rockport School Committee to order at 7:00 p.m. in the MS/HS Library. ### B. Budget Workshop/@Public Participation

Superintendent Liebow presented a 2017-2018 FY18 budget message and explained increases and decreases in the proposed final FY18 School Budget. The FINCOM produced a version of the School Department Reserve Account Analysis out to FY2023. Mr. Liebow explained that he has reduced the number of anticipated school choice students in the future do to the fact that birth rates are going down everywhere and Gloucester parents may choose to have their child stay in the Gloucester as their district moves forward. Colleen Coogan would like these documents on the school website. The FINCOM supports the Pre-school tuitions going into the SPED Reserve Fund to continue growth in that balance. Mr. Liebow will be meeting with the FINCOM and feels that he is presenting a very honest and transparent budget, along with giving them realistic scenarios of what can affect the budget in the future. The approved budget will be presented to the selectmen in December.

Mary Porter attended the RMHS School Council, the council is putting together a list of 4 or 5 similar school districts (possibly Millis/Georgetown) to visit to investigate how they manage scheduling, transitions for students from middle school to high school, internships, tech free time for students, and how they create teacher enthusiasm. RMHS Principal would like the council to be more focus in their mission and will come up with 4 or 5 topics/issues. Colleen Coogan would like to see an õExit Interviewö form for parents who send their child to other districts or private schools asking them what the other school had to offer that we dongt.

Rebecca Sly attended the elementary school council meeting and they discussed the teacher/parent conferences and how they can be improved and more productive. For the first time this year, parents will receive report cards before the conferences.

Colleen Coogan reported that she is not receiving communications from the middle and high school, where in the past she received a packet each week from the middle school. There was discussion as to the status of the website; Mr. Liebow will ask the IT department to post on the website that the district is still in the process of creating and adding information to the website.
